The Federal Reserve Chair is appointed for a fixed 4-year term and can only be removed for specific reasons. This legal protection shields them from political pressure. Interestingly, Trump nominated Powell in 2018, and Biden extended his term until 2026 in 2022.



Institutional integrity is extremely important for economic stability and trust.


Global Impact
