Majorana 1

- News: Microsoft has announced the arrival of Majorana 1, a new quantum chip that produces more reliable and scalable qubits than its predecessors. Qubits are the building blocks of quantum computers.
- Majorana 1 is an eight-qubit chip, which may seem modest when compared to quantum chips developed by rivals such as Google's Willow (106-qubit chip) and IBM's R2 Heron (156-qubit chip).
- However, the company said that Majorana 1's underlying Topological Core architecture allows for the quantum chip to be potentially scaled to a million qubits.
- Microsoft researchers have taken a unique approach by focusing on developing topological qubits, which are said to be more stable than traditional qubits and require less error correction from the start.
- Microsoft's purported breakthrough revolves around engineering a new type of quasiparticle known as Majorana.

Nature Restoration Law

- > It is the first continent-wide, comprehensive law of its kind.
- Member states must establish and implement measures to restore at least 20 per cent of its land and sea areas by 2030, under the legislation.
- ➤ A host of ecosystems are covered by the NRL, ranging from terrestrial, coastal and freshwater to forest, agricultural and urban.
- All ecosystems in need of restoration must be restored by member states by 2050.

PERIYAR

- □ Periyar E.V. Ramasamy (1879–1973) was the founder of the Self-Respect Movement.
 □ He held official positions of Frode that included the Chairmanship.
- □ He held official positions of Erode that included the Chairmanship of Municipal Council (1918–1919).
- President of the Tamil Nadu Congress Committee,he proposed a resolution regarding the rights of "Untouchables" to temple entry.
- After the local leaders were arrested Periyar led the Valkom
 Satyagraha movement and was imprisoned. The People hailed him
 as Vaikom Virar (Hero of Vaikom).
- □ He was disturbed by the caste-based discrimination in the dining hall at the Cheranmadevi Gurukulam (school). It was run by V.V.Subramaniam (a Congress leader) with the financial support of the Tamil Nadu Congress Committee.
- ☐ He quarrelled with Gandhi over the question of separate dining and left the congress

In the 1940s, Periyar launched Dravidar Kazhagam, which espoused an independent Dravida Nadu comprising Tamil, Malayalam, Telugu, and Kannada speakers.







Q. Estimate the contributions of Pallavas of Kanchi for the development of art and literature of South India. (UPSC 2024)

Contribution of Pallava dynasty

- Architecture:
 - ▶ The Pallavas were instrumental in the transition from rock-cut architecture to stone temples.
 - Pallava emperor Mahendravarman introduced the "Rock-cut" technique to South India for the first time and before that all temples were built from brick, mortar and perishable items.
- ► Sculpture and Paintings:
 - "Descent of Ganga", all people and animals offering their prayers and thank to Lord Shiva for giving the river Ganga to Earth.
 - Pallava paintings in Kailasanathar temple

Music and Literature:

- Rise in popularity of Tevaram written by Appar and Sambandhar.
- The music inscriptions of Kudumianmalai and Thirumayam indicate the Pallava kings interest in the music.

Governance:

- Possibility of well-designed and extensive water systems.
- During Narasimhavarman reign, Chinese traveller Hiuen Tsang visited Kanchipuram

Q. "Though the great Cholas are no more yet their name is still remembered with great pride because of their highest achievements in the domain of art and architecture. Comment" (UPSC 2024)

Contribution of Chola dynasty

Architecture

- The Dravidian Style got fully developed
- Chola temples showed socio-religious ideas of the Chola period.
 The Nataraja sculpture is famous not only for its beauty, but also for its spiritual significance.
- Realism dominated sculpture. Scenes from the Ramayanam, Mahabharata, Puranas, and the lives of the 63 Nayanmars are sculpted in narrative panels on temple walls.
- Scenes from Periya-puranam depicted in Kailasanathar temple in Kanchipuram through chola paintings

Music

- · In every temple, Aiwar and Nayanmar hymns were sung.
- Drums, veena, and flute were well-known musical instruments.

Drama

- · During the festival, two dramas were
- Performed: Rajarajeswara natakam and Rajarajavijayam.
 Ariyakuthu, Chakki koothu, and Santhi koothu are all mentioned in the inscriptions.

Dance

- During the Chola period, two types of dances were performed: Bharatanatyam and Kathakali.
 Governance
- Highly organized and efficient monarchic form of governance. The king was guided by a council of ministers
- Strengthening of local self-governance by giving autonomic powers to various public bodies and village councils.
- System of audit-control that made these local governing bodies accountable to the king.

Q. What are the causes of persistent high food inflation in India? Comment on the effectiveness of the monetary policy of the RBI to control this type of inflation.

(UPSC 2024)

Why food inflation in India persists?

- Local supply chain disruptions: Weather patterns and domestic policy decisions significantly impact food prices in India.
- Currency Depreciation: The depreciation of the Indian Rupee against major currencies can make imports more expensive, contributing to higher food prices domestically.
- Government Policies: Import restrictions, export bans, and changes in minimum support prices (MSP) for farmers can lead to price fluctuations independent of global trends.
- Global supply disruptions: India is significantly import-dependent on Edible oils and pulses.
- ► Rising domestic fuel prices
- ▶ Demand-Supply Mismatch

Globally, food inflation based on the FAO index has been in negative territory since November 2022. It's been the opposite in India, with the official consumer food price index inflation remaining stubbornly sticky and elevated – at 9.5% in Dec 2023.




