

#### Majorana 1

- News: Microsoft has announced the arrival of Majorana 1, a new quantum chip that produces more reliable and scalable qubits than its predecessors. Qubits are the building blocks of quantum computers.
- Majorana 1 is an eight-qubit chip, which may seem modest when compared to quantum chips developed by rivals such as Google's Willow (106-qubit chip) and IBM's R2 Heron (156-qubit chip).
- However, the company said that Majorana 1's underlying Topological Core architecture allows for the quantum chip to be potentially scaled to a million qubits.
- Microsoft researchers have taken a unique approach by focusing on developing topological qubits, which are said to be more stable than traditional qubits and require less error correction from the start.
- Microsoft's purported breakthrough revolves around engineering a new type of quasiparticle known as Majorana.

#### Nature Restoration Law

- > It is the first continent-wide, comprehensive law of its kind.
- Member states must establish and implement measures to restore at least 20 per cent of its land and sea areas by 2030, under the legislation.
- A host of ecosystems are covered by the NRL, ranging from terrestrial, coastal and freshwater to forest, agricultural and urban.
- All ecosystems in need of restoration must be restored by member states by 2050.

PERIYAR

Periyar E.V. Ramasamy (1879–1973) was the founder of the Self-Respect Movement.

He held official positions of Erode that included the Chairmanship of Municipal Council (1918–1919).

President of the Tamil Nadu Congress Committee, he processed a resolution regarding the rights of "Unbouchables" to temple entry.

After the local leaders were arrested Periyar led the Valkorm
Satyagraha movement and was imprisoned. The Velople hailed him as Valkom Virar (Hero of Valkom).

He was disturbed by the caste-based discommanation in the dining hall at the Cheranmadevi Gurukulam (school). It was run by
VV.Subramaniam (a Congress Committee).

He quarrelled with Gandin by et the question of separate dining and left the congress
